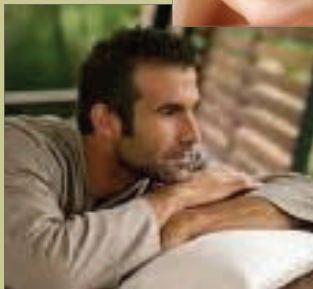
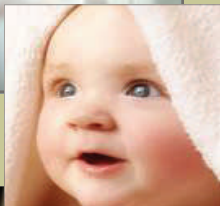
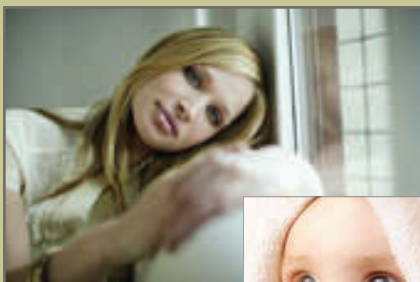

Some restrictions apply. See warranty certificate for complete details.

\*\* 1-year Assurance Replacement Limited Warranty: If the compressor, refrigerant coil or heat exchanger fails due to defect within the first year from the date of original installation of the product, Grandaire will, one time only, provide a comparable replacement unit. This warranty applies only to the original purchaser, only for owner-occupied dwellings, and is not transferable. This warranty is a supplement to the standard product limited warranty.
